1) REFUND POLICY: Once equipment has been issued & uniforms ordered, there are NO REFUNDS unless we are unable to field a team in your players' age group. Any refund issued will be minus a \$3.20 processing fee. All gear must be turned in. Refunds will be issued by CHECK only.

2) MEDICAL INSURANCE POLICY: YPAC insurance is "SECONDARY" to your personal insurance provider unless you don't have personal insurance then it is the primary. The insurance ONLY COVERS THE PLAYER during official game & practice times. It does not cover siblings or other persons injured on the property at any time. Per the agreement on the registration form, neither YPAC nor the SCHS can be held liable. YOU are responsible for your player outside of the official game & practice times and any other guests and siblings. i.e If a player is injured at 5:55 because they are goofing off before the official practice starts at 6:00, YPAC insurance cannot be used.

3) MANDATORY WEIGH-IN: Each player must be weighed in wearing their full gear and game uniform with an official GNCKYFL scale. This mandatory weigh in will be conducted during the Jamboree on Aug 3, 2019. If not weighed in during the Jamboree, your players' helmet will be marked with green tape and will be restricted to only certain positions and will not be able to run the ball. Plan vacations accordingly, no make-up weigh-in dates will be scheduled per GNCKYFL rules.

4) MANDATORY 10 PRACTICES: All players must attend 10 FULL practices before they are eligible to play in the 1st official game. Plan vacations accordingly, we will not hold special make-up practices.

5) FIELD ACCESS POLICY: Parents, family and siblings are **NEVER** allowed on the field during games or practices! This rule is strictly enforced by GNCKYFL & YPAC. The violator will be removed from that game/practice and could be banned for future games/practices depending on how serious the violation was. Only players, coaches and badge wearing GNCKYFL/YPAC staff are ever authorized on the field. Keep siblings and guest off of the football equipment. Only players are authorized to use any equipment.

6) GUEST POLICY: YOU are responsible for ALL guest at practice and games. Any policy or rule violations by you or your guest will not be tolerated. Action will also be taken against you if you are unable to keep your guests under control. You and your guest may be asked to leave a practice or games or may be banned from future practices or games along with your guest. The Parent Code of Conduct, YPAC by-laws & the GNCKYFL by-laws are posted on our website and you are responsible to abide by them and ensure your guests abide by them.

7) MANDATORY EQUIPMENT ISSUE: Sat, June 22 from 3-7 p.m./HS cafeteria. If you miss your equipment issue date, you will be considered a LATE registration since we will not have measured you for a game uniform and ordered it on time! At that point your will need to pay the additional \$40.00 for late registration! (\$140 total) Contact YPAC ASAP to arrange to be measured before June 20 if you cannot attend! **PARENT/PLAYER MTG:** Friday June 28 @ 6:30 P.M./HS cafeteria. This briefing will start your season off right! We will introduce coaches, game rules, parent/player expectations, explain practice and game schedules etc. If you miss the meeting, you will not be allowed to practice until the Athletic Director or Board President give you this briefing.
